Method 4: Financial Offer, Quality & Preferences	<ul style="list-style-type: none"> <li>Score quality, rejecting all tender offers that fail to score the minimum number of points for quality stated in the tender data.</li> <li>Score tender evaluation for financial offer.</li> <li>Confirm that tenderers are eligible for preferences claimed, and if so score tender evaluation points for financial offer.</li> <li>Calculate total tender evaluation points.</li> <li>Rank tender offers from the highest to number of evaluation points to the lowest.</li> <li>Recommend tenderer with the highest number of tender evaluation points for the contract, unless there are compelling and justifiable reasons not to do so.</li> </ul>
