- > Payment will be effected within 30 days from receipt of the invoice and all supporting documentation.
- > The municipality is not bound to accept the lowest or any Bid and reserves the right to not accept any quotation either wholly or a part thereof;

All quotations must be submitted in a sealed envelope at procurement office before/on the 06 September 2018 at 12H00 PM, the municipality is not liable to accept the lowest or any other tender.

Channels to be followed in the instance wherein the bidder is aggrieved by the decision taken by the BLM in the implementation of its SCM system, any matter arising from a contract awarded in the course of its SCM system or any matter arising from the contract.
