#### INTRODUCING THE FIRST CITIZEN OF BLOUBERG:

The people have spoken through a ballot, thus putting in power leaders they deem equal to the task to represent their interest at the municipal level and enhance service delivery. It is now time work...hard, time to walk the talk and deliver services to communities. Local government is the sphere of government closest to the people. The Blouberg citizens have entrusted their elected leaders with power to accelerate the delivery of services to their respective communities and improve their live-lihoods. Whoever is placed in the driving seat, has the responsibility to make sure that all citizens are provided with services to satisfy their basic needs.

## INTRODUCING THE FIRST CITIZEN OF BLOUBERG: COUNCILLOR MARIA NKHOLANE THAMAGA MAYOR

Maria Nkholane Thamaga has been mandated by the majority African National Congress (ANC) to lead the charge of ascertaining that the individual and collective basic rights as enshrined in the constitution are fulfilled. Born and raised in Seshego township in the late 50's, Cllr Thamaga like all at that time, experienced the hardships reminiscent of the apartheid legacy. There were very limited opportunities at that time which led to many kids leaving the province to seek green pastures outside the province. Most families prevented their girl children from going to school and Cllr Thamaga's educational journey was not an easy one. Her educational journey started at Mponegele Lower Primary school followed by Kgobokang Higher Primary School and to Mohlakaneng for secondary schooling. The difficult situations back then prevented her from continuing with her studies, but, that did not deter her from getting to the level she has set for herself in terms of education. Her passion for education and community development led her to Senwabarwana Adult Based Education and Training (ABET) where she continued with her studies.

She then proceeded to various institutions of learning where she enrolled for courses aligned to with her work and obtained certificates in Municipal Executive Leadership and Finance Management, Ethics Management in Local Government and Municipal Performance and Disaster Risk Management among others.

Maria Nkholane Thamaga - This name needs no introduction. Over the last two decades, this name became synonymous with service delivery and community development. Having served in the Council of Blouberg Local Municipality for over two decades, Cllr Maria Thamaga has experienced community hardships first hand. Her elections to take over the reigns of the mayorship of Blouberg fifth administration did not come as a surprise to many as her work speaks in volume.

Having served in Council for over two decades, Cllr Thamaga knows the municipality's hundred-and-thirty-seven(137) communities and their needs.

For 21 years, she has served in the Council, starting off as a Ward Councillor. Her hard work and passion to serve communities did not go unnoticed but saw her being elected the Council Speaker, a position she held for thirteen years; successfully presiding at meetings of the Council, passing resolutions for the development of the municipality and the betterment of the lives of its people, performs the duties and exercises the powers delegated to the Speaker by the Council, ensuring that the Council meets at least quarterly and ensure compliance in the Council and council committees with the Code of Conduct for Councillors as set out in Schedule 1 of the Municipal Systems Act among other functions.

Cllr Maria Thamaga is a seasoned politician. She joined the ANC back in the day when it was not fashionable to do so.

#### LEADERSHIP ROLES

From 2014 to date, Cllr Thamaga has been serving in the Peter Mokaba ANC Women's League as its Chairperson.

She is also serving as Member of the ANC Provincial Executive Committee (PEC)- 2018 to date. Serving as; Deputy Chairperson of the ANC Albert Luthuli Branch,

Chairperson of the ANC Albert Luthuli Branch for three consecutive terms, branch additional member for five years, additional member of ANC Women's League in the region for six years, Secretary of ANC Women's League of Albert Luthuli Branch and also served as Agent for her party, the ANC in 1994 and 1999 general elections respectively.

Cllr Thamaga also played a huge role in the development of her own community, Ga-Mochemi having served as the Secretary of Mochemi Traditional Council between 2007 and 2010 as well as chairperson for Feeding Scheme Committee at William Mochemi Primary School, Secretary of Region: Women In Partnership Against HIV/AIDS advocating for HIV/AIDS prevention. In 1996 she became part of the establishment committee of a community development project, Molemaphahlana Projects responsible for training women to sew utilizing sewing machines among other roles.

She was then a elected as Chairperson of Co-operatives at a regional level for three years, Secretary of Co-operatives at District level, as well as Deputy Secretary for Cooperatives at District level.

2009 - 2011 | Elected Blouberg Local Municipality Council Speaker while also serving as Ward 14 Councillor.

2011 - 2016 | Elected Blouberg Local Municipality Council Speaker and Proportional Representative (PR) Councillor responsible for ward 04 and 05.

2016 -2021 | Served as Blouberg Local Municipality Council Speaker and Proportional Representative (PR)Councillor responsible for ward 01, 21 and 22.

Cllr Thamaga selflessly served and continues to serve Blouberg communities with hard work and dedication and has been a beacon of hope to the hopeless and the less fortunate.

In her acceptance speech, she pledged to build a better Blouberg Local Municipality working with the Council collective.



Mushaisane Phineas Boloka, affectionately known as Blanco in both political and social

circles is a seasoned politician and community builder par excellence. Born and raised in the impoverished Ga Madibana village (Ward 09) of Blouberg Municipality, Boloka experienced poverty, impoverishment and deprivation first hand. That assisted in the shaping of his political pathway from his formative years. Like all his peers from those neck of the woods, life was not easy then given the scarcity educational (school) infrastructures compounded by distance and other socio economic factors. Only a fraction of his contemporaries managed to receive formal education.

However Comrade Blanco persisted, went through the local primary school, then headed to the adjacent Matswake Secondary School and on completion of his dues, he ultimately registered for a Teachers' Diploma at the then Bochum College of Education. It is precisely where the political bug bit him and he became actively involved in student politics under the banner of the South African Student Congress (SASCO). Upon completion of his studies and in search of employment prospects, Boloka then trekked to Gauteng

where he got his first gig as an educator at the MH Joosub Secondary School (Johannesburg) in the year 2000. Comrade Blanco quickly transitioned from student to labour union politics and was elected as local South African Democratic Union (SADTU)'s shop steward, a position he held until he left Gauteng in 2006. The desire to uplift his community saw Boloka leave behind the glitz and glamour of the Golden City as he relocated back to bowelakalana where he assumed a role as educator at the Masenwe Primary School. As fate would have it, he was once again unanimously elected shop steward for the selfsame union and retained the position until he left teaching for mainstream politics following the 2011 Local Government Elections. He then became Ward 09 councillor in the Blouberg Local Municipality under the auspices of the African National Congress. Due to his

political pedigree, Boloka became a District Representative in the Capricorn District Municipality (CDM) and subsequently became Member of the Mayoral Committee (MMC) responsible for Sports, Arts and Culture until 2016.

## INTRODUCING BLOUBERG LOCAL MUNICIPALITY'S SPEAKER:

His political resume and star continued to rise after the 2016 Local Government Elections as he became a direct Capricorn District Municipality representative. He then assumed a full time MMC position responsible for Finance Portfolio Committee which is no mean feat by any stretch of imagination. Intricacies around the sensitive subject of the public purse reside within the said Finance Portfolio Committee but Councillor Blanco proved his mettle and political astuteness by navigating the District Municipality's ship to consecutive Unqualified Audit Opinions. By virtue of his leading the District Municipality, it technically meant that he

also oversaw the financial performances of the four local municipalities (Blouberg, Molemole, Lepelle-Nkumpi and Polokwane) which also showed remarkable improvement under his tutelage.

Fast forward to November 2021 and following the much publicized and grueling local government elections held under the unforgiving Covid 19 conditions, Councillor Boloka was deployed back to where it all started – Blouberg Local Municipality -where he became Speaker of Council. In simpler terms he became Chairperson/Head of the legislative wing of council. Among a myriad of activities in the Office of the Speaker, the following reign supreme:

Duties of the Municipal Speaker include the following:

- Presides at meetings of the Council;
- Performs the duties and exercises the powers delegated to the speaker by the Council
- Must ensure that the council meets at least quarterly;
- Must maintain order during meetings;
- Must ensure compliance in the council and council committees with the Code of Conduct for Councillors as set out in Schedule 1 of the Municipal Systems Act; and
- Must ensure compliance in the council and council committees with the Code of Conduct for Councillors as set out in Schedule 1 of the Municipal Systems Act; and
- Must ensure that council meetings are conducted in accordance with the Rules and Orders of the council. In addition to the statutory functions listed the Office of the Speaker is also responsible for the functions listed hereunder:
- Encouraging participation of communities and community organisations in the decision-making process of the municipality
- Developing mechanisms to ensure and monitor participation of communities in the decision-making process;
- Ensuring that communities and

community organizations are educated on their rights and responsibilities to participate and give input to the municipality's policy development processes as well as planning and budget processes.

Asked in the backdrop of his election as Speaker of Council how he perceived the current public participation model and how he contemplated other innovations Councillor Boloka said," We have a very solid foundation which is revered countrywide. Our primary objective going

forward should be enhancing participatory democracy through civic education and resuscitation of organs of people's power. That will undoubtedly ensure inclusiveness of our communities and other stakeholders in all governance processes including but not limited to the IDP and Budget, People must also know mechanism at their disposal for them to participate in government programmes eg Motions, Petitions and Deputations. People must know the difference between IDP consultative and Municipal Public Accounts Committee (MPAC)'s Oversight Committee meetings just to cite a few. We need to ensure and sustain vibrancy hence the deliberate intent to undertake civic education." He concluded passionately.

Councillor Boloka's political profile include among others and besides having been a unionist; Secretary of the South African National Civic Organization (SANCO) Blouberg Sub Region from 2009 – 2015;

Secretary: Desmond Monyekgope Branch from 2007 - 2018; Deputy Secretary: ANC Blouberg Sub Region and is currently in his second tenure as Member of the Peter Mokaba Region having first been elected in 2018. The man is also no spring chicken in the education stakes and he has proven to have an insatiable appetite for books having amassed an array of qualifications to complement his initial education studies. He completed an assortment of qualifications ranging from Executive Leadership Management Development; Municipal Finance and Executive Management; Municipal Governance and Management Programmes; Human Resource Management; Project Management as well as Higher Certificate in Public Administration. Among reputable institutions he attended and attained the said qualifications are the University of Pretoria; University of Johannesburg; OR

School of Leadership and Regenesys.

If the passion, grit and determination shown by Speaker Blanco Boloka are anything to go by, Blouberg Municipality is definitely on the path to proverbial heights.

We have surpassed the Municipal Infrastructure Grant (MIG) spending norm of 40% by the end December 2021. Our spending is at 63%. This confirms the award that we have received on MIG projects performance. All our service providers are on site and hope we won't have any roll over projects during this financial

## **BLOUBERG LOCAL MUNICIPALITY RECEIVES ANOTHER UNQUALIFIED AUDIT OPINION**

The Blouberg Local Municipality has received an unqualified audit opinion for the financial year 2020/21. The municipality's audit report which covered 1 July 2020 to 30 June 2021 was presented by Auditor General of South Africa (AGSA) during Ordinary Council Meeting on January 27, 2022. The municipality also achieved an unqualified audit opinion for 2019/20 financial year.

The Mayor, Her Worship Cllr Maria Thamaga has welcomed the report and credited the good result to the management for putting in extra work to ensure that the public money is spent as it should be and accounted for. "My appreciation to the senior management and your support staff for putting together properly functional internal controls and ensuring implementation of action plans. We are proud to have, again, provided reassurance to our communities that their money is in good hands".

Mayor Thamaga commended the previous Audit Committee for its good work in the municipality. She said the municipality is now working towards attaining a clean audit and is without a doubt that the new committee will take the municipality to the greater heights, assist in realising that goal. "I wish to recognize and thank the previous Audit Committee for sterling work it has done. I have no doubt, that you will continue the good work done by previous committee and even help to us accomplish more. I am without doubt that that you will help us better coordinate municipal activities, improve the audit outcomes and address challenges facing our municipality".

Mayor Thamaga indicated that the municipality will continue to strive for good financial governance coupled with better services to communities and emphasizes that better audit outcome should be accompanied by service delivery. "Our ultimate goal is not only to obtain clean audit outcome, but also to have a clean administration that will be able to effectively deliver services to the community. We want to give people water, we want to give people electricity, improved audit outcomes must be accompanied by improved and effective service delivery. Our communities need services. Without effective service delivery to the communities, good audit outcomes means we will not make an impact in our communities".

An unqualified opinion is defined as an auditor's opinion that; the financial statements present fairly, in all material respects , the financial position of the municipality and it's financial performance and cashflows of the year in accordance with the Standards of Generally Recognized Accounting Practice (Standard GRAP) and requirements of the Municipal Finance Management Act (MFMA) of South Africa. Act 56 of 2003 (MFMA) and the Division of Revenue Act 16 of 2019 (Dora).

The Mayor of Blouberg Local Municipality, Her Worship Cllr Maria Thamaga on 09 December 2021, officiated three sod turning ceremonies marking the commencement of the regraveling and stormwater control projects.

Residents in these areas through community meetings have raised their concerns regarding the state of their roads and the municipality is now addressing their concerns as budget was set aside for the purpose.

The projects will be implemented on internal streets and access roads at Kwarung-Bosehla, Lebakong, Mokhurumela, The Glen and Eldorado respectively.

"Learners and residents in general here at Bosehla struggle to access schools and other areas during rainy seasons and the same problem at Lebakong village wherein cars are unable to access cemeteries during rainy season, polebearers are forced to carry coffins and walk to the grave yard during funeral events. At Mokhurumela village the problem is similar, rain water floods people's homes, that is why the municipality has set aside funds to address these challenges".

The municipality will implement regraveling and stormwater control projects in these areas coupled with installation of cul-

verts to ensure roads accessibility and that stormwater is channelled to right directions.



The Mayor introduced the contractors who will be implementing the regravelling and stormwater control projects - 4km internal streets and access road between Boshehla and Kwarung, 3km internal streets and access road at Lebakong village and another 3km of internal streets and access road at Mokhurumela. Residents have welcomed the projects and expressed their appreciation to the municipality for listening and addressing their challenges. "I'm very happy that, the municipality is here today to launch the regravelling project and introduce the contractor who will be working on our streets. These roads are bad, cars couldn't move easily but that won't be the case anymore after the completion of the project. Our appreciation to the municipality and Mayor Thamaga for bringing services to the people" said Lebakong resident, Masilo Mokgarihli.

On December 10, 2021 the Mayor successfully launched the regravelling projects for The Glen and Eldorado communities respectively. The Mayor, ClIr Maria Thamaga officiated the sod-turning ceremonies marking the commencement of the regravelling of the internal and access roads in these areas. The appointed service providers were introduced to the community. The projects are scheduled to run for three months.

## LEARDERSHIP MOTIVATES LEARNERS DURING BACK-TO- SCHOOL CAMPAIGN

The municipality from January 31, 2022, embarked on a 3-day(31- Jan - 02 Feb)Back-To-School programme to congratulate the 2021 Matric Class and motivate the Grade

12 Class of 2022 and learners in general as they commence the new academic year.

During the 3-day programme, the municipality visited best performing schools and those that performed poorly across all education circuits to motivate them to focus on their studies as early as the beginning of the year to achieve good

results at the end of the year.

The Mayor and his team, the Executive Committee(EXCO); Cllr Robert Makobela, Cllr Shirley Raphasha, Cllr Prince Motswabe and Ward 10 Councillor Hope Makhura who is also responsible for Special Focus programmes made their first stop at Seiphi Secondary School, Ga-Mochemi in Ward 14.

Seiphi, under Maleboho Central Circuit performed well by achieving an 84,6 % mark, an improvement compared to the previous year.

The second stop was Rakgari Secondary School at Montz Village, Ward 04.

This school, under Maleboho West Circuit recorded a 61,5% mark, a significant improvement compared to its 20% pass in 2020.

The Rakgari Secondary School management extended their gratitude to Mayor Thamaga whom they credited for the school's improvement for her motivation to the Class of 2021. The Mayor visited the school last year as part of the municipality's Back-To-School programme to monitor the school's readiness for the school year and to encourage learners following the poor performance the previous year. The school tripled the mark, by moving from 20% mark in 2020 to 61,5% in 2021.

Mayor Thamaga congratulated the schools for their improvement. She further adviced learners to concentrate on their studies and urged them to stay away from things that will hamper their progress.

"Stay away from people and things that

are going to disturb your from studying. Your focus should be education and nothing else. Again, your



disadvantaged background should not stand on your way to success. Work hard, pass well, the government will provide funding for you to further your studies in order to improve your life and that of your families. My office has also set aside funds to assist those that are in need of funds for the registration for their studies in higher institutions of learning".

At Seiphi, the school management raised challenges; including lack of storage for text books, parents' interference on school work, while at Rakgari the issue of alcohol consuming by some learners, unsupportive parents towards school work and loud music from taverns disturbing the teaching and learning activities cited as some of the contributing

factors to the school's poor performance.

The schools presented their strategies for further improvement on results and learners made an undertaking to the Mayor to achieve a 100% pass rate.

In response, Mayor Thamaga indicated that the municipality will engage all the parties involved in a bid to remedy the situation.

The Speaker, Cllr Blanco Boloka and his team visited Rapetsoa Secondary School at Grootdraai village in Ward 05. The school under Maleboho West Circuit produced a 61,5% mark.

The Chief Whip , Cllr Johanna Rangata visited Tshenyane Secondary School at Ga-Hlako, Ward 03. The school achieved 43,2%.

The municipality concluded the 2022 Back- to-School campaign by visiting two schools in the Bahananwa Circuit on February 02. Mayor Thamaga and her team visited Mantshako Secondary School at Eusoringa Village, Ward 16 wherein the grade 12 class of 2021 achieved a 41,3% mark and Mathipa Makgato Secondary at Ga-Makgato in Ward 15. Mathipa Makgato achieved 27, 8% pass rate.

The Speaker, Cllr Blanco Boloka and the Chief Whip Cllr, Johanna Rangata and their teams visited Radikgwebethe Secondary School (87,9%, Maleboho Central Circuit), Inveraan Village, Ward 09 Maphutha Secondary School (46,2%, Maleboho East Circuit), Indermark Village, Ward 12, Madikweng Secondary School (85,0%, Bochum West Circuit), Earlydawn Village, Ward 01 and Bodiela Secondary School(48,5%, Bochum West Circuit), at Uitkyk No1 in Ward 01.

The municipality also donated school shoes, backpacks and sanitary towels in all the schools visited to be distributed to needy learners.
