CALL IS MADE FOR NOMINATION OF PERSONS TO BE APPOINTED AS MEMBERS OF THE BLOUBERG MUNICIPAL PLANNING TRIBUNAL IN TERMS OF THE SPATIAL PLANNING AND LAND USE MANAGEMENT ACT, 16 OF 2013.



Subsequent to a Blouberg council resolution number C (93.1), the Blouberg Local Municipality hereby call for nominations of persons to be appointed as members of the Municipal Planning Tribunal in terms Section 35(1) and 36 of the Spatial Planning and Land Use Management Act, 16 of 2013, read together with Section 33 of the Blouberg Local Municipality Spatial Planning and Land Use Management By-law, 2017.

Field of interest are: Town Planning, Law, Engineering, Environmental Sciences/ Management, Financial sector, Land surveying and Economist.

The following incumbents are required to be nominated in the Municipal Planning Tribunal:

- Two professional planners registered with the South African Council for Planners in terms of the Planning Profession Act, 2002 (Act 36 of 2002), as may be amended from time to time;
- A person who is registered as a Professional with the Engineering Council of South African in terms of the Engineering Profession Act, 2000 (Act No. 26 of 2005);
- An environmental management specialist who is registered with a voluntary association;
- A person either admitted as an attorney in terms of the Attorneys Act, 1979 (Act No. 53 of 1979) or admitted
 as advocate of the Supreme Court in terms of the Admission of Advocates Act, 1964 (Act No. 74 of 1964);
- An economist or economic development specialist;
- A person who is registered as a professional Land Surveyor in terms of the professional and Technical Surveyor's Act, 1984 (Act No. 40 of 1984), or a geomatics professional in the branch of land surveying in terms of Geomatics Profession Act, 2013 (Act No. 19 of 2013); and
- Any other person who has knowledge and experience of spatial planning, land use management and land development or the law related thereto.

Requirements:

Applicant must be persons registered with the relevant professional bodies, who have leadership qualities and who

have knowledge and experience of spatial planning, land use management or the law related thereto.

The name and address of the nominator, who must be a natural person and a person, may nominate himself or

herself;

(a) Motivation by the nominator for the appointment of the nominee to the Blouberg Municipal Planning Tribunal.

(b) A short curriculum vitae of the nominee.

(c) Certified copies of qualifications and registration certificates indicating registration with the relevant professional

body or voluntary association.

(d) Letter of acceptance of the nomination from the nominee.

NB It must be noted that nominees will be vetted before appointment is made.

Disqualification: Please note that failure to comply with the above requirements and the provisions of section 38

(1) of the Spatial Planning and Land Use Management Act (Act 16 of 2013), may result in the disqualification of the

nomination.

Term of Office: Successful candidates will be appointed for a period of three years calculated from the date of

appointment.
