

  - Attach fully completed **MBD4, MBD6.1, MBD8** and **MBD9** downloadable from Municipal website, [www.blouberg.gov.za](http://www.blouberg.gov.za)
  - The Master Registration Number or Tax compliance status pin or a valid copy of tax clearance certificate
  - Original or Certified copy of the up-to-date statement of Municipal rates and taxes and municipal service charges for company and company owners/directors (not more than three months and not in areas) and if renting a lease agreement with proof of payment. If the bidder is operating where municipal rates are not applicable, a certified (not more than three months) copy of residence from the traditional authority must be submitted.
  - Bank rating Code A-C; Joint venture agreement in cases of a joint venture pages must be printed according to colors indicated on the table of content.
