Certified copy or copies of Identity Document (ID) for Director(s). Proof of registration on Central Supplier Database [At least 3 months valid] detailing all compliance requirements of the company. Copy of Tax Compliant Status issued by SARS(TCS); Original or Certified copy of the up to date statement of Municipal rates and taxes and municipal service charges for company and company owners/directors (not more than six months and not in areas) and if renting a lease agreement with proof of payment. If the bidder is operating where municipal rates are not applicable, a certified (not more than six months) copy of residence from the traditional authority must be submitted. Bank rating Code A-C; Joint venture agreement in cases of a joint venture pages must be printed according to colors indicated on the table of content.

Tender closure is as per the table above, public opening will follow immediately after closure. Tender Documents must be submitted at the reception area of our Municipal Office in Senwabarwana, in a sealed envelope clearly marked with Project Name and Number. Telegraphic, Telephonic, facsimile, e-mailed and late Tenders will not be accepted. The Municipality is not obliged to accept the lowest or any tender.

The following condition will apply:

- Channels to be followed in the instance wherein the bidder is aggrieved by the decision taken by the BLM in the implementation of its SCM system, any matter arising from a contract awarded in the course of its SCM system or any matter arising from the contract. (Regulation 49 & 50 of MFMA 56 of 2003)
- The written dispute must be lodged within 14 days of decision to the BLM and attention to Makwela M(015 505 7100)
- The dispute, objection, complaint or query may be referred to the relevant provincial treasury if, it is not resolved within 60 days or no response is received from the municipality within 60 days.
- If the provincial treasury does not or cannot resolve the matter, the dispute, objection, complaint or query may be referred to the National Treasury for resolution.
