Some nineteen years down the line, we still remain trendsetters on matters of enhancing participatory democracy. We are undoubtedly the first to establish functional ward committees and put up a budget for ward committees' support. We also say without any shadow of doubt that we are the proud copy right owners of the concept of ward committees' conference, which has become an annual event for many municipalities in and outside our District and Province. In a rare and quite monumental feat, there has been seventeen uninterrupted ward committees' conferences that have been held thus far.

The current financial year's instalment of the conference, held from the 28th – 30th August 2019 at Miami Lodge (Polokwane), was a mixture of the fanfare and hard work particularly on both the educational and capacity building fronts. The gumption with which speaker after speaker narrated Blouberg Municipality's state of participatory democracy as they waxed lyrical of the immeasurable strides made, had commentators going green with envy. When all was said, the conference went into the rigours of commissions to masticate prevalent problems and come up with at times unpleasant but yet diagnostic recommendations that would assist in turning around the service delivery challenges that bedevil the institution.

Further elucidation on the 16th Annual Ward Committees' Conference and resolutions/declaration thereof find expression elsewhere in the edition. We remain the authors of the Council/EXCO Outreaches wherein all our quarterly

council and monthly Executive Committee meetings are held outside council parameters, in the process affording communities the opportunity to directly interact and raise issues with the top most governance structures.

Our outreaches have over the years grown immensely in stature and quality. Not only have we excelled in conceptualization of these and other mechanisms to shoot up participatory democracy, we have perfected them through monitored implementation over the years, In our quest to fortify what's arguably the most dominant force in the public participation stakes, all issues raised by ward committees and at all public participation for a serve in all governance structures including but not limited to; Portfolio, Executive, Petitions and Public Participation Committee as well as departmental and management meetings. The objective thereof is to ascertain that all issues raised receive the requisite attention to their logical conclusions. The stakes have evidently been upped and the onus lies with our contemporaries to "catch us if they can". In our relentless effort to have innovations towards building on paths towards a municipality that is efficient, effective, accountable and responsive we are on the verge clinching an abler that will make communication with all stakeholders as seamless as possible. Our ward committees have since inception been honouring their scheduled bi-monthly meetings without fail.

Mention has to be made of the fact that these ward committees do not meet for the sake of meeting, but meet over structured agenda to assess and further strategise on implementing their approved annual programmes, which include educating and mobilizing members of the public around the municipality's programmes.

Suffice to mention that council has also approved the realignment of the ward committees' portfolios/desks in line with recommendations of the Provincial Department of Cooperative Governance, Human Settlements and Traditional Affairs (CoGHSTA) for a uniform approach.

The proposed changes are however, very cosmetic with the most significant being that ward secretaries are no longer responsible for any particular desk but will focus solely on the coordination aspect of such committees. All wards also held their mandatory public (report back) meetings. Given the amount and quality of inputs our people make in the public participatory platforms, it has become abundantly clear that our ward committee system is fully functional. It is that time of the year where we keep our fingers crossed in the hope that we will achieve a better audit opinion. Notwithstanding all the capacity and human resource



constraints, we remain steadfast. It is envisaged that given the commitment shown throughout the year, the ball will drop our way. We further urge our management to unequivocally devote their full cooperation to the entire audit process. It should be recalled that the process spells out the state of our being in respect of both financial and performance aspects of our management. As institutional political principals, we however commit to accept full responsibility of whatever outcome the AG would have arrived at. The audit process looks more like an insurmountable task but we would like to urge everyone concerned to subscribe to the dictum, "sort out today's problems today, because if you leave it until the end of the week, you will have a week's problems to solve in one day".

It will be a travesty of justice on my part if I do not mention my utter disdain at the level of femicide and violence against women and children that continue to ravage our communities week in and week out. We are making an impassioned plea to the male folk to desist from and abhor such actions in the strongest possible terms. The detesting of such dastardly deeds should culminate into enlisting of law enforcement agencies at the slightest sign of such manifestation as failure to report a crime renders one a criminal himself/herself and may have one liable for prosecution. The upcoming festivities should be enjoyed with family and friends and we must leave no margin for error where are women and children are concerned. It'd be appreciated if people could realize that they have the potential to bring change to our beloved country as Antony Robbins remarked, 'Each of us is endowed with innate resources that enable us to achieve all we've ever dreamed of and more.

ADMINISTRATIVE OVERVIEW

Upon closure of the 2018/19 curtains we quickly open the 2019/20 door with enthusiasm and determination. Determined to ensure that as the Municipality we build on the success of the preceding year into the future. Key amongst critical aspects that we are faced upon entering into 2019/20 are the following; implementation of cost containment measures, improved audit outcome for 2018/19, services to the people, Municipal connectivity et cetera. Implementation of cost containment measures

The Minister of Finance issued cost containment regulations 2019 that affected how Municipalities should go about conducting their business with view of containing costs. This was as a result of the financial pressures cost by poor performance of the economy and revenue generation. Municipalities were requested to develop their own policies in line with the regulation. This policies must be implemented with effect from 01 July 2019.

In line with developments Blouberg Municipality developed and approved the Cost Containment policy. And this affected some of the budget line items that were already budgeted in the 2019/20 budget. Amongst area affected are the following:

- Attendance of conferences
- Catering
- Sports programmes
- Subsistence and travel
- Et cetera

Improved audit outcome for 2018/19

The Municipality has obtained a qualified audit opinion for the year 2017/18. This year we have received a qualified opinion on cash flow. We have made huge improvements and we never thought of a qualified opinion this time around. We appreciate the work and contribution of our key stakeholders (Auditor General South Africa-AGSA, Capricorn District Municipality-CDM, Cooperative Governance Human Settlements and Traditional Affairs - CoGHSTA, Treasury, and South African Local Government Association -SALGA etc). We will continue to strive for an improved audit opinion.



SERVICES TO THE PEOPLE

As Blouberg Municipality are committed towards ensuring that we provide service to our Communities. We have already appointed for all MIG projects and work is underway and we will complete these projects in time.

All Integrated National Electrification Programme (INEP) projects are at tender stage for appointment of contractors. Completed these electricity projects we provide electricity to households. Over and above implementation of the 2019/20 Capital projects we have conducted a retreat session during the month of July 2019. This session provided an opportunity for us to look at our strength, weaknesses, opportunities and threats and how do we move forward. A roadmap has been developed and this will help us to improve. This roadmap will guide our planning and budgeting.

MUNICIPAL CONNECTIVITY

The Municipality is busy with the project of connectivity. This project entails ensuring that all satelites IT system are linked to those of head office at Senwabarwana. Upon completion of the project it will be easier for customers to pay services in any Municipal office closer to them. It will further improve accessibility of Municipal services to our Communities.

NEW POWER STATION FOR SENWABARWANA, INTERNAL STREETS AND STORMWATER PROJECTS FOR GA-MAKGATO AND MAROBJANE

A successful sod turning ceremony held on December 11 2019, officiated by the Mayor, His Worship Cllr Maseka Pheedi marked the beginning of another development of an electrical power station. The project is a partnership between the Blouberg Local Municipality and the Department of Energy in a bid to alleviate pressure on the grid in the town of Senwabarwana.

The site adjacent to the Senwabarwana Sport Complex was officially handed over to the contractor who broke ground with the expected construction period being five months.

Meanwhile , the 08th and the 09th of October 2019 were joy-filled days for the residents of Ga-Makgato and Marobjane villages as Blouberg Local Municipality launches the 5th phase of the internal streets and storm water projects. Acting Mayor on the day, Cllr William Ntlatla officiated the sod-turning ceremonies respectively. The projects are schedule to run for 8months.

Following the residents' complaints regarding bad internal roads condition during public consultations on IDP/Budget processes previously, the council of Blouberg Local Municipality resolved to implement the internal streets projects in these two villages.

Cllr Ntlatla siad the projects will boost the economy in these areas as temporary employment will be created during the construction stage. Members of the communities extended their gratitude to the municipality for the projects.

The chairpersons of the portfolio committees on Infrastructure Development and Special Focus, Cllr Simon Mashalane and Cllr Makhalemela Makhura also graced the occasions.

BLOUBERG MUNICPALITY HOST SUCCESSFUL WARD COMMITTEES CONFERENCE

The 17th Annual Ward Committees Conference saw the ward committees, community development workers, the Council, Executive Management, Makgosi and other stakeholders converge at Miami Lodge in Polokwane in the Capricorn District to tackle issues of service delivery, how best they can work together to serve the community of Blouberg as well as sharing challenges and successes

Today, Blouberg Local Municipality is hailed champions of public participation throughout the country because of, amongst other things; the effectiveness of its ward committees system. Blouberg Local Municipality has always regarded its ward committees as the important mobilizing agent for community action. The 22 wards translate into 220 ward committee members. Each ward is manned by 10 committee members who are selected from a broad range of interest groups that are most relevant to the key performance areas of the municipality and the government in general. The areas include services such as water and sanitation, electricity, housing, roads, storm-water and drainage, waste and environment and social services including health, safety and security among others. The Blouberg Annual Ward Committees' Conference dates back from 2003 and has been running throughout the years without fail.

The conference was held under the theme: "Rise of the New Dawn: Ward Committees leading the charge towards the khawuleza trajectory". President Cyril Ramaphosa has called on all spheres of government to move with speed in attending community challenges and delivering services to the people. "Khawuleza" which means "hurry up" is the name which seeks to improve government service delivery and development. Delivering the keynote address, the Mayor, His Worship Cllr Maseka Pheedi said it is time to khawuleza – move with speed to attend to the community challenges. Mayor Pheedi also called on ward committee members to always avail themselves when communities

need them. He further indicated that ward committees play a major role in enhancing participatory democracy. "Ward committees help enhance public participation which is vital part of our democracy, which allows for citizens to involve in how their communities are governed".

Ward Committees and councillors' hard work did not go unnoticed as various categories in recognition of their outstanding performances and contributions to community development were in place. The three-day conference concluded with resolution on how to fastrack the delivery of services to the Blouberg citizenry.

The Blouberg Municipality still has its hands firmly gripping the public participation domain. This statement was backed up during the South African Local Government Association/SALGA Peer Recognition Certificates Awards hosted by the Extended SALGA Provincial Speakers' Forum held earlier this year. Blouberg Municipality swept the boards in all categories entered namely: Best Public Participation Model, the Most Functional Schedule of Meetings as well as the Most Functional Municipal Public Accounts Committee (MPAC).

WOMEN-OWNED ENTERPRISES GET SPONSORSHIP TO EXHIBIT AT THE AFRICAN AGRI INVESTMENT INDABA

Two local farming businesses that are part of the Acceleration of Women-Owned Micro-Enterprises (AWOME) programme, received an opportunity to exhibit their products at the 4th Annual African Agri Investment Indaba (AAII) in Cape Town, thanks to a partnership by UN Women and African Agri Council.

Matome Cynthia Mokgobu of Mosebudi Trading Enterprise and Shonisani Ndou of Gran and VV Crop Farming, were among 700 delegates from governments, banks, investors, commercial farmers and the agro-processing industry at the AAII to discuss trends that are likely to influence food and agribusiness economics in Africa for the next decade. The two female entrepreneurs from Blouberg and Musina municipalities were selected from the AWOME capacity-building programme launched by De Beers Group and UN Women; with training carried out by local NGO Hand in Hand Southern Africa.

The AWOME programme addresses the capacity of women entrepreneurs primarily in the informal sector to apply business management skills that promote the sustainability and growth of their businesses in order to create more and better jobs for the entrepreneurs and their communities.

The programme's training modules include business planning, costing, marketing, record-keeping, stock control, and people and productivity. Matome Cynthia Mokgobu (26) from Gemarke Village in Blouberg believes she is going to

change the world through farming by creating employment and contributing towards the shortage of food in Africa. She is currently the only young person in her community who owns a 19-acre farm, which produces pepper, butternut, beetroot and spinach. She employs two part-time workers from her community.

Matome thanked De Beers Group, UN Women and Hand in Hand trainers for the experience: "Thank you for giving farmers like me from rural areas an opportunity to network and sell our businesses to other African countries. I can assure you that as Africans, we're going to change our economies by creating jobs for our fellow Africans through agriculture, food security and alleviating poverty."

Shonisani Ndou (43) from Malale Village in Musina, is the founder of VV Crop Farming which produces crops such as tomatoes, chillies, okra, baby marrow and green beans at her 30-hectare farm. She is a supplier for big brands such as All Joy Foods, Tiger Brand SA and the Johannesburg Fresh Produce Market; and has created 5 permanent jobs and employs 85 part-time workers from her community.

Speaking about her experience at the AAII, Shonisani said: "I was so happy because there were so many investors and other business owners at the Indaba. We shared learnings on how to run our businesses better. It is not always easy but with the trainings I have attended, I know that I have grown to be a better businesswoman."

A SHOT IN THE ARM FOR DITHEBELE ME CLOTHING AND BOTALA TEMONG FARMING

Two local businesses now have the adequate equipment to increase their production, thanks to Blouberg Local Municipality. The Mayor, His Worship Cllr Maseka Pheedi on the 3rd of July 2019 officially handed over a brand new embroidery machine to Dithebele ME Clothing as part of local enterprise development initiatives which play a vital role in growing the economy and creating jobs for locals.

In his 2019/2020 budget speech, Mayor Pheedi indicated that municipalities have been mandated to provide financial support to emerging local businesses, "the constitution of the Republic of South Africa, Act 108 of 1996 section 154 stated quite implicitly that the local government has a constitutional mandate to improve the social and economic development. In respect of this mandate the municipality must ensure that it plays a pivotal role on Small Medium Micro Enterprises (SMMEs) development". He stated.

Dithebele ME Clothing: The journey began two decades ago (1999) when the late Mme Elizabeth Mogadi Seakamela from Marobjane Village saw a gap in the market and grabbed it. Following her passing in 2016 his son Lerapela Seakamela took over the business as its managing director and he's been running it successfully. The business so far has created four jobs to locals and operates from Senwabarwana industrial area.

Before the financial injection from the municipality, Dithebele ME Clothing used to outsource the very machinery which set them back thousands of rands on monthly basis." With the assistance of this new machine from our municipality, we will

no longer hire, now the business will be profitable, we will appoint two more people to work here. Thank you Blouberg Local Municipality for supporting SMMEs" Seakamela said.

Seakamela was also trained in Records Keeping, Marketing, Costing and Planning For Your Business, Buying, Stock Control and People Productivity. The training was facilitated by the Blouberg Local Municipality in partnership with UN Women in a bid to assist him run the business professionally. Dithebele ME Clothing makes different garments with school uniform being their core business.

On the other hand, a borehole and fencing material for 2ha were procured for Botala Temong Farming owned by Maropeng Rasekgoalo, a young male farmer from Borkum in Ward 08. Rasekgoalo commenced with crop farming activity in 2013 with just a land from his backyard and now he's been allocated 11ha piece of land for production purposes.

Due to challenges of fencing the entire working space and lack of agricultural implements such as tractor and dripping system he will, for now utilize least 2ha of the land. His produce are currently sold at big supermarkets such as Boxer Supermarket and Gosiame and taken to City Deep and RSA (marketing agent). Maropeng Rasekgoalo recently scooped second position at the district level for Young Subsistent Farmer and R25 000.00 cash prize which assisted him to purchase other agricultural implements needed to expand his business. This farmer has created employment to four labourers and intends to hire two more people.

Launched in March 2011, nine years later the Blouberg Local Aids Council is still continuing to coordinate and support local implementation of the National Strategic Plan for HIV/ AIDS and provide a necessary institutional mechanism for an integrated local government response to the dreaded disease.

The Municipality has set up local AIDS Councils in all 22 wards which are fully functional to date making it the best in the province in terms of coordination and scooping various awards for the well coordination as a result.

The council sits on quarterly basis to discuss Blouberg multi-sectorial HIV/AIDS / sexual transmitted infections (STIs)/ tuberculosis (HAST) reports and discuss prevention campaigns and strategies.

Government has also setup AIDS council at national, provincial and district levels to bring together government services, Non-governmental Organizations (NGOs) and community organizations in the fight and continuing struggle

to ward-off the devastating effects of HIV/AIDS. The Blouberg Local Municipality Local Aids Council consists of a team drawn from different institution including government departments, traditional authorities, and representatives from civil structures with Mayor Maseka Pheedi as chairperson deputized by Mr Alex Bale.

Part of their responsibilities amongst others is to: Monitor and evaluate AIDS programmes within Blouberg Municipality.

Coordinate and build partnership and ensure effective communication with all relevant stakeholders.

Collate and distribute information for the effective implementation of HIV and AIDS responses within Blouberg. Get involvement in the Blouberg Municipality's IDP planning and implementation.

Support local role players within Blouberg municipal area who are providing HIV and AIDS services.
