## Boks must never fear Ireland and Scotland, says Beast

TENDA! Beast' Mtawarira believes that the Springboks have nothing to fear from Ireland or Scotland when they face the two teams later this year at the World Cup in France.

The Irish and Scots are currently unbeaten in the Six Nations and when the World Cup is france.

The Irish and Scots are currently unbeaten in the Six Nations and when the World Cup starts on September 8 in 200 days' time, the Boks will have to contend with both teams in Pool B of the tournament.

Ireland, in particular and with all due respect to Scotland, as the top ranked side in the world, will be a massive encounter that the Boks will have to overcome if they are to make a statement of intent in defence of the Webb Ellis Cup, won in 2019.

As intimidating as that proposition looks right now, World Cup winner and Bok legend Mtawarira insists that Ireland and Scotland will never be able to dominate the Boks, and therein lies the key to victory.

"We must never be alraid," Mtawarira said in an exclusive interview with Independent Media on Saturday. "We must show, as a Bok, you are going to have to play your best game when you play against Ireland and Scotland is 1 is a fight. Those teams have been building a lot of momentum over the last couple of years."

"Scotland has had an injection of South African players as well, and they have been getting better. Ireland has been the No 1 team over the last few years.

"When we play them, we are coine to have to him our best. It


